Dear Ms. Hildebrand: I write to make the following suggestions:

- **DRAFT: Hazard Mitigation Addendum:** Would suggest in this form permitting revisions that would support not only the structural changes discussed such as building elevation, communication system enhancements and water control but also additional changes that could support infrastructure use as resilience hubs and cooling centers. Cooling centers as defined by the Centers for Disease Control and Prevention are Cocation[s], typically an air-conditioned or cooled building that has [have] been designated as a site to provide respite and safety during extreme heat. More broadly, resilience hubs can support day-to-day needs such as health and social services, recovery, and emergency response activities. Additional structural changes may be required, however, to support such uses beyond those encompassed in the current draft form.
- With respect to this form's discussion of energy facility or systems, some institutions, including hospitals, are emphasizing solutions such as microgrids in lieu of or as a complement to generators.³ It may be helpful to clarify whether such alternative power projects can receive public assistance funding.
- **DRAFT: FEMA Form FF-104-FY-22-233 Organization Profile**: this form lists "(Optional) Climate Adaptation Plan." Would define what is meant by climate adaptation and broaden to include resilience and mitigation (also defining these terms). In addition to the CDC's Social Vulnerability Index, consider referencing other similar tools such as the Environmental Justice Index or NIH's HDPulse. In the question on underserved communities, consider also referencing persons with chronic medical conditions (including behavioral health needs), persons with physical disabilities, tribal populations (AI/AN) and/or persons in poverty.
