Categorical eligibility errors in verification documentation include: invalid case numbers, categorical eligibility claims known to be false, and invalid categorical standards.

Gross income calculation errors in the verification process include: incorrectly calculating household size, incorrectly determining the frequency of receipt of income, not converting multiple income sources to annual income, not counting the child in the list of household members or counting the child twice, incorrect arithmetic, misclassifying reportable income, and other income computation errors.
