We have over 2100 international students and are quite familiar with this form. Our F-1 students often use the I-539 for Reinstatement and for Change of Status applications. Please find my suggestions below.

Part 1 Item #11

Please add a check box for D/S. Most of our F-1 students have I-94s for Duration of Status and do NOT have a specific departure date to provide for a date field.

Part 3 Item #1

Again, if the student is applying for F-1 (or J-1) status, he or she will be requesting their status be extended for "D/S" (Duration of Status) You could provide a checkbox for D/S and you could mention it is only an option for people in eligible statuses (i.e. F-1 or J-1) The applicant should have an option to put in a date OR check D/S.

Part 4 Items 1.a. and 1.b.

I really don't know what you are asking for here. When you say "For Principal Applicant", won't that ALWAYS be the person listed in Part 1 on the I-539?????) This info was already requested under Part 1 Items 9.d. and 9.e. so I don't think you want the same info again.

What are you really wanting to gather here? Are you wanting info on a primary if a dependent is applying for a benefi? If an H-4 is applying for a COS are you wanting the H-1Bs passport info? Is there a better way to clarify what you are asking and in what circumstances? Maybe clarify, if you have a dependent status (e.g. H-4 or F-2), please provide the Principal's passport info...

#### Part 1 Item #11

Please add a check box for D/S. Most of our F-1 students have I-94s for Duration of Status and do NOT have a specific departure date to provide for a date field.

#### Part 3 Item #1

Again, if the student is applying for F-1 (or J-1) status, he or she will be requesting their status be extended for "D/S" (Duration of Status) You could provide a checkbox for D/S and you could mention it is only an option for people in eligible statuses (i.e. F-1 or J-1) The applicant should have an option to put in a date OR check D/S.

### Part 4 Item #18

I fear people may overlook the info below #19 which starts "If you answered "Yes" to number 18...." I recommend putting this paragraph immediately below #18. In other words, move up the paragraph that starts "If you answered "Yes" to number 18" to be part of 18. You could just say, "If you answered yes....." (like you have done with question 20)

#### Part 4 Item #19

With this question, you want additional info if the person marks yes or no. Students OFTEN overlook this so I recommend mentioning additional info is required. For example:

19. Have you, or any other person included in this application, been employed in the United States since last admitted or granted an extension or change of status? (Note additional info is required. See below)

Also, it gets really wordy referring to "Part 4 (continued) Additional Information for Answers to Numbers 18 and 19". Two suggestions: Either 1) Add this section to Part 4 and place it immediately below question 19 OR 2) leave it near the end of the form and rename it Part 9 or Supplement 1 to direct people to the end of the document.
