Page 1

Page 1

Page 8 – About You > Immigration

The top question is about "immigration status at time of must recent arrival". Then the second question is asking if the person entered under the Visa Waiver Program. Is it not possible to add a layer of logic here and only ask for the additional VWP info if the person selects they entered under VWP from the drop down above? In my mind, if I just said I entered as F-1, I don't understand why you are asking if I entered under VWP?

Page 16 - Eligibility Information > Education Information.

The question is "Are you a B-2 visitor applying to extend your stay, or are you applying to change your status to that of an F-1 or M-1" If yes, the person is asked to provide who will provide financial support.

It seems there is only place to list one individual plus a scholarship. It is possible the student may have more than one source. Please consider adding an option for additional sources of funding.

Page 17 – Eligibility Information > J1/J2 Visa

It asks if the person is currently in J-1 or J-2 status. (apparently after the person has already been asked about current immigration status). Any way to use behind the scenes logic to know this without asking again? The system should know if the person already indicated their status.

Page 21 - Supplemental Biographic Information > Employment History

Is this only for past employment? IF the person is currently employed, do you want a "Date Employment Ended" Is there a way to add a checkbox for "Still currently employed at time of application"

Page 22 - Supplemental Biographic Information > Education History

Again – how is one supposed to record current educational institution? Is there an option to add a box for "currently attending" next to the Date of Attendance To that wants a specific end date?

Page 23 – Supplemental Biographic Information > Residence History

Again, how can one indicate where currently residing?
