 - For 8 hours per day, Monday through Friday, of the grader's time excluding 8 hours on Federal legal holidays on which no work is performed, at the hourly rate prescribed in Section 54.27, "Fees and other charges for service," as amended (or portion thereof, if more than one applicant). At any time that the services of the official grader are not required by the applicant(s), he/she maybe utilized elsewhere for the performance of Federal grading and certification service. Credits for service so performed elsewhere (Monday through Friday) will be allowed to the applicant(s) (or prorated to the applicant(s) to cover their unused hours) so long as allowable credit hours plus hours actually worked for the applicant(s) do not exceed 8 hours per day, Monday through Friday, excluding Federal legal holidays.
 - For hours worked in excess of 8 hours per day Monday through Friday (or portions of 8 hours if more than one applicant) and all hours worked on Saturday or Sunday, except Federal legal holidays, at the rate prescribed in Section 54.27, as amended.
 - For work performed on Federal legal holidays at the rate prescribed in Section 54.27, as amended.
 - The costs for transportation, mileage and per diem incurred by the grader in performing grading or certification at the applicant's request in accordance with d. Section 54.27, as amended.
