Major Changes to the 2007 Form 8915

- Part I was deleted. Qualified hurricane distributions cannot be made after 12/31/2006. (IRC 1400Q) (I-Plan 65.00051) Subsequent parts and lines were renumbered.
- In Part II (new Part I):
 - Lines 8 through 11, used to report current year distributions, were deleted.
 - New line 2 was added to be used to bring forward the amount from line 11 of the 2006 Form 8915.
- In Part III (new Part II):
 - Lines 20 through 26, used to report current year distributions, were deleted.
 - New line 11 was added to be used to bring forward the amount from line 26 of the 2006 Form 8915.
- Year and line references were updated as appropriate throughout the form.
