Your answers are confidential and protected by law. All U.S. Census Bureau employees have taken an oath and are subject to a jail term, a fine, or both if they disclose any information that could identify you or your household. Title 13, Section 196, of the United States Code authorizes the Census Bureau to conduct this Special Census and Section 9 of this law assures that your answers will be kept confidential.
