<b>Description:</b>	All instructors are required to submit to MSHA the names of persons who have satisfactorily completed required electrical training. MSHA uses the form information to issue certification cards to those persons who are qualified.

<b>Legal Authority:</b>	30 CFR <a href="#">75.153(g)</a> and <a href="#">77.103(g)</a> require that an individual who is a qualified electrical person in accordance with Section 75.153 and 77.103 shall annually certify to the district manager that he has satisfactorily completed a coal mine electrical retraining program approved by the Secretary in order to retain that qualification.
