Model Qualified Diversified Trust Provisions

The model qualified diversified trust agreement contained in this memorandum is made available by the U.S. Office of Government Ethics to attorneys for their use in drafting proposed trust agreements to be submitted for certification pursuant to section 102(f)(4)(B) of the Ethics in Government Act of 1978 (Pub. L. 95-521, as amended) and subpart D of 5 C.F.R. Part 2634. Under the statutory scheme, a trust agreement is not permitted to be recognized as creating an efficacious blind trust arrangement for any purpose under Federal law unless it had been certified by the Office <u>prior</u> to its execution. Proposed trust drafts submitted to the Office for consideration must adhere to the language of the model except to the extent, as agreed to by the U.S. Office of Government Ethics, that variations are required by the unusual circumstances of a particular case. The fiduciaries' certificates of independence must be executed in the exact form indicated.

It is strongly recommended in any case in which the use of a blind trust is contemplated that the Office be consulted as early as possible. Prospective trustees or their representatives should schedule an appointment with the staff of the U.S. Office of Government Ethics for an orientation to the specialized procedures and requirements which have been established by law with respect to blind trust administration prior to the certification of the trust. As a condition of approval by the Office, prospective trustees must exhibit a familiarity with and commitment to the specialized nature of blind trust administration.

The primary purpose of this Trust is to confer on the Trustee the sole responsibility to administer the trust and to manage trust assets without the participation by, or the knowledge of, any interested party or any representative of an interested party. This includes the duty to decide when and to what extent the original assets of the trust are to be sold or disposed of and in what investments the proceeds of sale are to be reinvested. Accordingly, the Settlor and the Trustee agree as follows:

FIRST: (A) This Trust shall terminate upon the first to occur of the following –
(1) Settlor's ceasing for any reason to serve as ______ and in any other position to
which he may have been subsequently appointed in the Federal Government and Settlor
thereafter giving Trustee written notice directing that this Trust be terminated; or (2) Settlor's
death or incompetence. The period between the date of this agreement and the termination of the
Trust shall be called the "Trust Term".

(B) Notwithstanding Paragraph (A) of this Article FIRST, this Trust agreement
may in addition be terminated through revocation. However, within thirty days of dissolution of
the trust, the interested party shall file a report of the dissolution and a list of the assets of the
trust at the time of dissolution, categorized as to value in accordance with 5 C.F.R.
§ 2634.301(d), with the Director of the U.S. Office of Government Ethics.

(C) The Trustee and the interested parties may amend the terms of this trust
agreement only with the prior written approval of the Director of the U.S. Office of Government
Ethics and upon a showing of necessity and appropriateness.

SECOND: The Trustee in the exercise of its authority and discretion to manage and control
the assets of this Trust shall not consult or notify any interested party or any representative of an
interested party.

(A) The assets initially placed in Trust hereunder, as listed in annexed 1 THIRD: Schedule B, shall consist of a widely-diversified portfolio of readily marketable securities. None 2 3 of the assets is prohibited as a holding by any interested party by the Act and regulations promulgated thereunder, and other applicable Federal laws, Executive orders, and regulations, or 4 consist of securities of entities having substantial activities in the area of the Settlor's primary 5 responsibility within the Federal government. 6 7 (B) The portfolio shall be deemed to be widely-diversified if – 8 9 (1) the value of the securities concentrated in any particular or limited economic 10 or geographic sector is no more than twenty percent of the total, and 11 12 (2) the value of the securities of any single entity (other than the United States 13 Government) is no more than five percent of the total value of such assets. For purposes of this 14 paragraph (B), securities issued by the United States Government are obligations of the United 15 16 States. 17 18 (C) A security will be deemed readily marketable, for purposes of this Article THIRD, if -19 20 (1) daily price quotations for the security appear regularly in newspapers of 21 22 general circulation, and 23 24 (2) the Trust holds the security in a quantity that does not unduly impair liquidity. 25 26 (D) Each asset listed in annexed Schedule B is free of any restriction with respect to its transfer or sale except as fully described in such Schedule B. 27 28 (E) During the Trust Term, the interested parties shall not pledge, mortgage, or 29 30 otherwise encumber their interests in the property held in trust hereunder. 31

16	any representative of an interested party and the Trustee with respect to the Trust unless the		
17	communication is in writing and has the prior written approval of the Director, U.S. Office of		
18	Government Ethics, and unless it relates only –

20	(A) To a request for a distribution of cash or other unspecified assets of the trust,		
21			
22	(B) To the general financial interest and needs of the interested party (including,		
23	but not limited to, a preference for maximizing income or long-term capital gain), or

25	(C) To information, documents, and funds provided by, or needed from, the		
26	Settlor, to effectuate the provisions of Paragraph (B) of Article SIXTH of this Trust, with respect		
27	to any income tax obligation arising otherwise than with respect to the property held in Trust

5 NINTH: The interested parties and any representative of an interested party shall not take 6 any action to obtain, and shall take reasonable action to avoid receiving, information with respect 7 to the holdings of, and the sources of income of, the Trust, including obtaining a copy of any 8 Trust or individual tax return filed by the Trustee or any information relating thereto, except for 9 the reports and information specified in Article SEVENTH of this Trust.

11 TENTH: The Trustee shall file with the Director, U.S. Office of Government Ethics, by the 12 May 15th after any calendar year during which the Trust was in existence a properly executed 13 Certificate of Compliance in the form prescribed in Appendix B to 5 C.F.R. Part 2634. In 14 addition, the Trustee shall maintain and make available for inspection by the U.S. Office of 15 Government Ethics, as it may from time to time direct, the Trust's books of account and other 16 records and copies of the Trust's tax returns for each taxable year of the Trust.

(2) the ownership of which is prohibited by, or not in accordance with, Title I of 1 the Act (and the regulations thereunder), the terms of this Trust, or other applicable statutes and 2 3 regulations; 4 (C) Solicit advice from any interested party or any representative of an interested 5 party with respect to this Trust, which solicitation is prohibited by any provision or requirement 6 of Title I of the Act (and the regulations thereunder) or this Trust; or 7 8 (D) Fail to file any document required by Title I of the Act (and the regulations 9 thereunder) or this Trust. 10 11 12 TWELFTH: The Settlor shall not knowingly and willfully, or negligently – 13 14 (A) Solicit or receive any information with respect to this Trust that may not be disclosed pursuant to any provision or requirement of Title I of the Act (and the regulations 15 16 thereunder) or this Trust, or 17 18 (B) Fail to file any document required by Title I of the Act (and the regulations thereunder). 19 20 21 THIRTEENTH [**Optional provision**]: Subject to such amounts as the Trustee may from 22 time to time reserve for the payment of such income taxes as may be due and payable by the 23 Trust, and for payment of expenses and compensation as provided for in this Trust, during the 24 Trust Term the Trustee shall pay to the Settlor \$_____ at the beginning of each month. 25 26 FOURTEENTH: In addition to the rights, duties, and powers conferred upon the Trustee by law, the Trustee shall have the following powers, rights, and discretion with respect to any Trust 27 28 property held by it: 29 (A) To sell, exchange, or otherwise dispose of the property in such manner and 30 31 upon such terms as the Trustee in its sole discretion shall deem appropriate;

29	and also to extend the time of payment of any loans or encumbrances which at any time may be

4	(H) To register any property belonging to the Trust in the name of its nominee, or

9	whether such claims shall increase or decrease the assets held under this Trust agreement;

11	(J) To determine whether or to what extent receipts should be deemed income or
12	principal, whether or to what extent expenditures should be charged against principal or income,
13	and what other adjustments should be made between principal and income, provided that such
14	adjustments shall not conflict with well-settled rules for the determination of principal and
15	income adjustments, or the Uniform Principal and Income Act, if in effect in the State of
16	;
17	
18	(K) To determine whether or not to amortize bonds purchased at a premium;
19	
20	(L) Except to the extent otherwise expressly provided in this Trust agreement, to
21	make distributions in kind or in cash or partly in each and for such purposes to fix, insofar as
22	legally permissible, the value of any property;
23	
24	(M) To pay such persons employed by the Trustee to assist it in the
25	administration of the Trust, including investment counsel, accountants, and those engaged for
26	assistance in preparation of tax returns, such sums as the Trustee deems to be reasonable
27	compensation for the services rendered by such persons. Such persons may rely upon and
28	execute the written instructions of the Trustee, and shall not be obliged to inquire into the
29	propriety thereof;
30	

1	(N) No person may be employed or consulted by the Trustee to assist it in any
2	capacity in the administration of the Trust or the management and control of Trust assets,
3	including investment counsel, investment advisers, accountants, and those engaged for assistance
4	in preparation of tax returns, unless the following four conditions are met –
5	
6	(1) when an interested party or any representative of an interested party learns
7	about such employment or consultation, the person must sign the Trust instrument as a party,
8	subject to the prior approval of the Director of the U.S. Office of Government Ethics,
9	
10	(2) under all the facts and circumstances, the person is determined pursuant to the
11	requirements for eligible entities under 5 C.F.R. § 2634.405(c) to be independent of any
12	interested party with respect to the trust arrangement,

14	(3) the person is instructed by the Trustee or other designated fiduciary to make
15	no disclosure publicly or to any interested party or any representative of an interested party that
16	might specifically identify current Trust assets or those assets which have been sold or disposed

20	no direct communication with any interested party or any representative of an interested party,
21	and that any indirect communication with an interested party or any representative of an
22	interested party shall be made only through the Trustee pursuant to Article EIGHTH of this

25	(O) Except as specifically limited in this Trust agreement, to do all such acts,
26	take all such proceedings, and exercise all such rights and privileges, although not otherwise
27	specifically mentioned in this Article FOURTEENTH, with relation to any such property, as if
28	the Trustee were the absolute owner thereof, and in connection therewith to make, execute, and
29	deliver any instruments and to enter into any covenants or agreements binding the Trust.
30	

FIFTEENTH: Notwithstanding the provisions of Article FOURTEENTH of this Trust, 1 the Trustee shall not acquire by purchase, grant, gift, exercise of option, or otherwise, without the 2 3 prior written approval of the Director of the U.S. Office of Government Ethics, any securities, cash, or other property in addition to that listed in the annexed Schedule B, from any interested 4 party or any representative of an interested party. 5 6 SIXTEENTH: The Trustee shall not at any time be held liable for any action taken or not 7 taken or for any loss or depreciation of the value of any property held in the Trust whether due to 8 an error of judgment or otherwise where the Trustee has exercised good faith and ordinary 9 diligence in the exercise of its duties such as would have been exercised by a prudent person. 10 11 12 SEVENTEENTH: No Trustee hereunder shall be required, in any jurisdiction, to furnish any bond or other security, or to obtain the approval of any court before applying, distributing, 13 selling, or otherwise dealing with property. 14 15 16 EIGHTEENTH: Except as provided in Article SEVENTH of this Trust, the Trustee shall make no accounting to the Settlor until the date of termination of this Trust, and, at such time, it 17 18 shall be required to make full and proper accounting and turn over to the Settlor all assets of the Trust then held by it the said Trustee. 19 20 NINETEENTH: The Trustee (and any substitute or successor) shall have the right, by a 21 22 duly acknowledged instrument delivered to the Settlor to resign as Trustee in which event the Settlor shall designate and appoint a substitute or successor Trustee (subject to the prior written 23 24 approval of the Director, U.S. Office of Government Ethics) in its place and stead, which shall have all of the rights, powers, discretions, and duties conferred or imposed hereunder upon the 25 26 original Trustee. 27

TWENTIETH: Any amendment of the terms of this Trust Agreement, including the
appointment of a substitute or successor Trustee, shall require the prior written approval of the
Director of the U.S. Office of Government Ethics, upon a showing of necessity and

- 1 appropriateness. Any such substitute or successor Trustee shall have all of the rights, powers,
- 2 discretions, and duties conferred or imposed hereunder upon the original Trustee.

Privacy Act Statement

Section 102(f) of the Ethics in Government Act of 1978 as amended (the "Ethics Act"), 5 U.S.C. Appendix, § 102(f), and subpart D of 5 C.F.R. part 2634 of the regulations of the U.S. Office of Government Ethics (OGE) require the reporting of this information for the administration of qualified trusts under the Act. The primary use of the information on the trust instrument prepared based in part upon this model draft document is for review by Government officials of OGE and the agency of the Government employee for whom the trust is being established to determine compliance with applicable Federal laws and regulations as regards qualified trusts. Additional disclosures of the information in the trust document itself may be made:

- 1) To disclose the information furnished by the reporting official, in accordance with provisions of section 105 of the Ethics in Government Act of 1978, as amended, to any requesting person.
- 2) To disclose pertinent information to the appropriate Federal, State, or local agency responsible for investigating, prosecuting, enforcing, or implementing a statute, rule, regulation, or order where the disclosing agency becomes aware of an indication of a violation or potential violation of civil or criminal law or regulation.
- 3) To disclose information to another Federal agency, to a court, or a party in litigation before a court or in an administrative proceeding being conducted by a Federal agency, either when the Government is a party to a judicial or administrative proceeding or in order to comply with a subpoena issued by a judge of a court of competent jurisdiction.
- 4) To disclose information to any source when necessary to obtain information relevant to a conflict-of-interest investigation or determination.
- 5) By the National Archives and Records Administration or the General Services Administration in records management inspections conducted under authority of 44 U.S.C. 2904 and 2906.
- 6) To disclose information to the Office of Management and Budget at any stage in the legislative coordination and clearance process in connection with private relief legislation as set forth in OMB Circular No. A-19.
- 7) To disclose information to the Department of Justice, or in a proceeding before a court, adjudicative body, or other administrative body before which OGE is authorized to appear, when: OGE; or an employee of OGE in his or her official capacity, or any employee of OGE in his or her individual capacity (where the Department of Justice or OGE has agreed to represent the employee); or the United States (when OGE determines that litigation is likely to affect OGE), is a party to litigation or has an interest in such litigation, and the use of such records by the Department of Justice or OGE to be relevant and necessary to the litigation provided, however, that the disclosure is compatible with the purpose for which such records were collected.

- 8) To disclose the public financial disclosure report and any accompanying documents to reviewing officials in a new office, department or agency when an employee transfers or is detailed from a covered position in one office, department or agency to a covered position in another office, department or agency.
- 9) To disclose information to a Member of Congress or a congressional office in response to an inquiry made on behalf of an individual who is the subject of the record.
- 10) To disclose the information to contractors, grantees, experts, consultants, detailees, and other non-Government employees performing or working on a contract, service, or other assignment for the Federal Government, when necessary to accomplish an agency function related to this system of records.

Penalties

Knowing or willful falsification of information on the trust document prepared from this model draft or failure to file or report information required to be reported under Title I of the Ethics Act and 5 C.F.R. part 2634 of the OGE regulations may lead to disqualification as a trustee or other fiduciary as well as possible disqualification of the underlying trust itself. Knowing and willful falsification of information required under the Ethics Act and the regulations may also subject you to criminal prosecution.
