The Bureau of Economic Analysis (BEA) strongly supports the extension proposed by the Bureau of Labor Statistics (BLS) for the Consumer Price Index (CPI) Housing Survey. This survey is the basis for two BLS price indexes that are used to deflate key components of BEA's economic statistics.

BEA uses information from this survey to estimate gross domestic product (GDP) in the national income and product accounts, and to prepare the input-output (I-O) accounts and GDP by industry accounts. The CPIs for residential rent and owners' equivalent rent are used to prepare real (inflation-adjusted) estimates of the housing services component of personal consumption expenditures (PCE) in GDP and the rental income component of national income. The resulting PCE estimates are used to prepare real estimates of gross output and PCE in the annual and benchmark I-O tables and to prepare real estimates of GDP by industry. The CPI for rent of primary residence is also used to estimate real state and local consumption expenditures of "other" rental services in GDP. A list of items used is presented in the attached table.
