Dear Mr. Thompson:

The American Immigration Lawyers Association (AILA) submits the following comments in response to the above referenced 60-Day Notice and request for comments published in the Federal Register on October 25, 2018.¹ This notice of information collection solicits comments on the H-2A temporary agricultural employment-based visa program, which includes Form ETA-9142A, ETA 790/ETA 790A, related appendices, and applicable instructions.

AILA is a voluntary bar association of more than 15,000 attorneys and law professors practicing, researching, and teaching in the field of immigration and nationality law. Our mission includes the advancement of the law pertaining to immigration and nationality and the facilitation of justice in the field. AILA members regularly advise and represent businesses, U.S. citizens, lawful permanent residents, and foreign nationals regarding the application and interpretation of U.S. immigration laws. We appreciate the opportunity to comment on the H-2A temporary non-agricultural labor certification program forms and believe that our members' collective expertise provides experience that makes us particularly well-qualified to offer views on this matter. We appreciate the Department of Labor's (DOL) desire to enhance the quality, utility, and clarity of the information collected, while minimizing the burden on stakeholders and maintaining a streamlined and efficient application process. It is in this same spirit that we offer the following comments.

As an initial matter, AILA greatly appreciates the Department of Labor's efforts to streamline the H-2A process by proposing to issue electronic certifications. We believe this action will significantly improve the H-2A process without jeopardizing the integrity of the H-2A program.

Form ETA-790/790A, Addendum A and ETA-790A Form Instructions: H-2A Agricultural Clearance Order

General Comment

We understand the Department of Labor's interest in modifying the H-2A forms to ensure that there is consistency between the Form ETA-790 and Form ETA-9142A. However, as a general matter, we are concerned that by not allowing employers to submit attachments to the forms to more fully describe the material terms and conditions of employment, there may not be enough text space to properly respond to specific questions. We also note that none of the questions on the new forms include Spanish translations and there is no space to include such a translation. Since the Form ETA-790 and ETA-790A/Addendum A represent the H-2A contract that must be provided to H-2A and corresponding employees, we recommend that the Department of Labor include either a Spanish version of the forms or additional space to include the Spanish translation on the existing proposed forms.

Form ETA-790

1. Section II: Employer Contact Information

We recommend that the Form ETA-790 include a question (Section II, Proposed Number 17) to include the employer's state unemployment or tax identification number which is used by many State Workforce Agencies to verify an employer's existence and simplify the process to open a clearance order.

Also, we recommend that Section II, number 14, "Business e-mail address" should be made optional.

2. Suggested Section: Attorney/Agent Contact Information:

The Form ETA 790 should contain a section to provide the employer's attorney or agent contact information, including name, address, FEIN, telephone number and email address.

Form ETA-790A and Addendum A

1. Section III A. Job Offer Information

A5. Anticipated days and hours of work per week:

We recommend including a text box in this section to allow for a fuller description of the number of hours to be offered to agricultural workers. While we understand the need to streamline the review process, prohibiting employers from including attachments or addendums and requiring all information about hours to be included in Section A5., may result in an employer's inability to provide material information about the terms and conditions of employment. (i.e. Whether overtime may be requested or required; whether occasional work on Saturdays or weekends may be rested or required, etc.).

A6. Hourly work schedule:

We recommend including a text box to permit employers to explain that daily start and end times may vary, for example, due to weather conditions and crop readiness.

A7a. and A7b. and Addendum A (a.1 and 2 and b. 1 and 2) Name of Crop or Agricultural Activity and Description of the job duties to be performed:

The proposed Forms ETA-790A and ETA-790A Addendum A appear to limit the number of crop or agricultural activities that can be performed to only those that will now fit in the space provided on the forms. We recommend that the Department of Labor permit employers to continue to include attachments to the job order to more fully describe the job duties to be performed.

In addition, it is not clear if ETA-790A, Questions A7a. and A7b. as well as Addendum A, Crop or Agricultural Activity Information 1 and Crop or Agricultural Activity Information 2 pertain to multiple crop/agricultural activities or whether only a single crop/agricultural activity can be included in each of the three limited spaces available. We assume that employers can include multiple crop or agricultural activities in each of the text spaces available since there is space to identify up to 5 different wage rates for each of the activities. However, as this is not clear, we recommend that the form instructions state that multiple crop/agricultural activities may be included in each of the "job duty" text spaces provided in ETA-790A and Addendum A. Alternatively, we recommend that the Department of Labor pluralize the headings in Questions 7a. and Addendum A to state, "Name of Crop or Agricultural *Activities*" and include an instruction that permits an employer to submit multiple Forms ETA-790A Addendum A if additional space is needed.

A7c-A7f: Wage Offer Information

In Item 7d., we recommend creating two boxes entitled "Hour" or "Month" for employers to provide a unit of pay in one or the other, as directed in the instructions for ETA-790A.

Additionally, it is very common for multiple piece rates to apply to different types of agricultural commodities and for different types of pack per variety. For example, in celery harvesting, there may be up to 25 different piece rates that apply to different packs of celery.² Likewise, for lettuce, different piece rates apply to romaine, iceberg, mixed leaf, green life, romaine hearts etc. with a different piece rate applicable to different packs within each variety. Again, there may be over 40 applicable piece rates. The proposed forms, including Addendum A, provide space to identify only up to 6 different piece rates. Therefore, without attachments, employers will be unable to provide a full disclosure of wages. This is especially true because the form instructions for Item 10, "Additional conditions about the wage offer(s)", expressly request employers to exclude piece rate information provided in 7f. We recommend that a text box be added to address this issue of limited space.

A10. Additional conditions about the wage offer(s):

The form instructions require employers to include in Item A10. information about production standards, bonuses, and/or other expenses that will be paid by the employer. According to the instructions, piece rate information should not be included in the space provided. Many agricultural employers include substantial and critical information in this section including complex bonus and incentive systems, holiday pay, jury duty, special benefits, and if a collective bargaining agreement (CBA) exists, required incentive pay items from a CBA. We anticipate that there will not be enough text space to accurately disclose additional wage information in this text box and note that there is no space on the Addendum A to provide additional information of this nature as well. As such, we recommend that additional space be provided for this item or that the Department of Labor permit a separate attachment to be included.

A11. Deductions

We appreciate the Department of Labor using a text box for information about deductions rather than the current Form ETA-790 which includes only boxes to check off. The proposed item A11. affords employers the flexibility needed to address different tax and benefit deductions applicable to H-2A and corresponding domestic workers, among other information that may be applicable.

2. Section III B: Minimum Job Qualifications/Requirements

We believe that this section may have insufficient space to identify special requirements applicable to the job offered. Similar to other sections in the proposed forms, we recommend that more space be added or that the Department of Labor permit a separate attachment to be included.

3. Section III C: Worksite Information and Addendum B

We have reviewed the comments prepared by the Florida Fruit and Vegetable Association (FFVA) for this form and join in its comment regarding Addendum B. At the time of filing, it is impossible to provide information about the specific dates that workers will be assigned to a specific worksite within the dates of need. It is also impossible to provide the exact number of workers that will be assigned to a particular worksite on such specific dates (Question C.a.3 and C.a.4). This is especially the case for H-2ALCs who will work at multiple worksites—sometimes over 40 or more worksites --during a given H-2A contract period. We also note that FFVA's comment is not limited to the citrus industry—it would be applicable to virtually all agricultural activities where multiple worksites exist. Weather and market conditions change dramatically each year and throughout a specific season. Therefore, we recommend that the Department of Labor remove questions C.a.3 and C.a.4 concerning begin and end dates on the proposed Addendum B form and permit (and instruct) employers to include in Item 10 "Additional Worksite Information", the approximate period of time that agricultural workers may be assigned to a particular worksite, which may be the same as the employer's overall H-2A period of need.

We also agree with FFVA's comment about the form limitations on the number of worksites. Current job orders can list far more than the 5 locations permitted on ETA-Form 790A and Addendum B. Currently, employers fill out a chart listing all worksites and include the chart in an addendum to the Form ETA-790.³ This process is already arduous, without the prospect of needing to complete multiple Form Addendum Bs, assuming that submitting multiple Addendum Bs would be permitted. We estimate that completing each item requested in Addendum B would add an additional 10-15 hours, at a minimum, in preparation time for most H-2A applications. Moreover, assuming Addendum B would be part of the H-2A contract that is required to be provided to H-2A and corresponding domestic workers, this alone would add an additional 75 pages or more to the contract. This will inevitably cause a great deal of confusion for agricultural workers and will require a great deal of paper.

We recommend that the Department of Labor continue to allow employers to submit an attachment identifying its itinerary and the worksites where work will be performed throughout the H-2A season.

4. Section III D: Housing Information and Addendum B

We recommend that the Department of Labor remove Item 9. This question requests employers to identify which housing standards apply—Local, State or Federal. This question is best presented to the housing inspection authority that conducts the housing inspections as employers may not know which standard the inspector has or will rely upon. In California, for example, many local townships, cities and counties adopt local standards that frequently change.

5. Section III H: Other Material Terms and Conditions of the Job Offer

We encourage the expansion of this text box and suggest that the Department of Labor add an option for attachments to accommodate individual job order specifications. By doing so, it may not be necessary to add other attachments as recommended herein, apart from Addendum B items.

6. Section III I: Conditions of Employment and Assurances: Number 8:

We recommend that the Department of Labor carefully review this attestation to ensure that it is consistent with the regulation set out in 20 CFR 655.122(i). Specifically, we recommend removing the last sentence in the second paragraph referring to "8" hours a day which refers to an example provided in the regulations. This form is signed under penalty of perjury and should not contain items that are not required by law.

1. Appendix A, Section A. Attorney or Agent Declaration:

A5. Signature

The instructions for Item 5 in Appendix A, Section A are to enter the email address of the attorney/agent representing the employer in filing the application, but the space provided on Form ETA 9142A only seeks a signature and does not provide space or heading for an email.

A6. Date Signed

The instruction for Item 6 in Appendix A, Section A states the attorney/agent must sign the form. However, the space provided on Form ETA9142A requests the "Date signed".

Conclusion

We appreciate the opportunity to comment on the proposed changes to the H-2A temporary agricultural labor certification program forms and applicable instructions. We look forward to a continuing dialogue with the Department of Labor on these issues.
