


Figure 1: NFU Reporting - Yes




Figure 2: Measurement Specification 1




Figure 3: Measurement Specification 2




Figure 4: Date Range




Figure 6: Denominator Representation 2




Figure 7: Denominator Representation 3




Figure 8: Performance Measure 1




Figure 9: Performance Measure 2




Figure 10: Performance Measure 3




Figure 11: Performance Measure 4




Figure 12: Performance Measure 5




Figure 13: Other Performance Measure




Figure 14: Deviations from Measure Specifications 1




Figure 15: Deviations from Measure Specifications 2




Figure 16: Deviations from Measure Specifications 3




Figure 17: Deviations from Measure Specifications 4




Figure 18: Optional Measure Stratification 1




Figure 19: Optional Measure Stratification 2




Figure 20: Optional Measure Stratification 3




Figure 21: Optional Measure Stratification 4




Figure 22: Optional Measure Stratification 5




Figure 23: Final Comments and Report Documents




Figure 24: NFU Reporting - No - 1




Figure 25: NFU Reporting – No – 2
