Narrative: On July 23, 2014 at approximately 14:17 hours, I received a call from Blaine County Communications for a report of a "drone" which was harassing a "spray plane." I contacted Robert J. Nash, the pilot of an Air Tractor agricultural application aircraft, who said he had seen a "drone" following him as he was spraying a field near Price Lane in Blaine County, Idaho. I asked Nash about the drone and he said it was being piloted by an individual who was maneuvering the craft near the path of his spray plane, and he only missed the drone by approximately 10 feet. I asked Nash if he knew what type of drone it was and he stated a "Phantom." I told Nash I would attempt to locate the owner of the drone and explain to him the amount of damage which could occur to the Air Tractor and Nash if he was to cause the drone to strike Nash as he was completing his contract work. Nash works for Thomas Helicopters out of Gooding, Idaho.

I went to 112 Price Lane and spoke with Brandon E. Jones, who said he would see if he could locate who was operating the drone and have the individual contact me. I later received a phone call from Jeremy S. Lato. Lato stated he had been operating his DJI Phantom 2 drone when the Air Tractor was spraying the field next to the area where he was piloting his drone. I explained to Lato if he was

to cause his drone to hit the spray plane he would cause significant damage to the plane and possibly cause it to crash. I also told Lato if his drone was to cause an injury to the pilot of the Air Tractor he could have charges pressed against him by the Prosecuting Attorney's Office for what injuries had been sustained by the pilot. I also explained to Nash the incident would then be turned over to the Federal Aviation Administration and most likely they would seek federal charges against him for the incident. Lato was very apologetic and stated he had no intentions of causing any damage or injury to anyone. I also told Lato the Air Tractor is operating on a commercial agriculture permit which allows it special exemptions for the legal distance the aircraft would typically be required to stay away from certain residences and structures.

I called Nash back after I spoke with Lato and he stated he did not want me to pursue the incident any further if Lato did not harass him any more when he was flying his Air Tractor in the area.

Nothing further at this time.
