Hello Mr. Mills

Thank you for sending the revised allocation and expenditure reports. On behalf of Ryan White Clinics for 340B Access (RWC-340B), we would also like to thank HRSA for recognizing the increased burden that reporting program income in the expenditure report would impose on Ryan White HIV/AIDS Program (RWHAP) recipients and removing this requirement from the revised expenditure reports. However, we are hoping you can provide clarification on whether this applies only to Parts A and B recipients, or Parts C and D recipients as well.

The 30-day notice that was issued on June 26, 2020 states that "HRSA removed a request to require RWHAP Parts A and B recipients to report program income and pharmaceutical rebates information in their expenditures report." Although the 30-day notice only mentions Parts A and B recipients, we noticed that the program income column was removed from the revised Parts C and D expenditure reports. Can you please confirm that Parts C and D recipients will no longer be required to report program income and pharmaceutical rebates information in their expenditure reports?
