Ms. Agnew

I'm glad to explain my views.

I'm in Hong Kong, so I have no access to U.S. law books. Therefore, I can't confirm whether judicial approval of use of a penalty-of-perjury clause is only for the IRS, or whether the holding can be applied to government agencies generally. Counsel for the State Department should research this issue.

It appears to be legal overkill to have a penalty-of-perjury statement above a signature line on a State Department form. The State Department has ample legal protection, including the specific prohibition against a false statement on a passport-application form filed with the State Department and the general prohibition of making a false state of citizenship to a government agency.

It may be desirable to add a penalty-of-perjury clause to induce fear in someone who files a form, but that is different.

My reference to "statement of obligation" intends all language above a signature line, other than a penalty-of-perjury clause. For example, Form DS-64 obligates a signer to aver that he has not given his passport to someone. Likewise, DS-86 obligates a signer to aver that he did not receive a passport book. Even of the State Department may require a penalty-of-perjury declaration, there is no authority for requiring any other declaration or any representation above the signature line,

New items: (1) The question on Form DS-64 about submitting the form in connection with an application for a new passport is superfluous. The answer is, "Yes. Of course," No regulation requires a statement about the unavailability of a valid or potentially-valid passport, other than at the time that a replacement passport is applied for, and then only if the application is made within the 10-year or 5-year period of .validity. A citizen who chooses to apply for a new passport 11 years (for example) after issuance of his lost or stolen passport need not account for it.

(2) Form DS-64 calls for disclosure of a filer's social-security number. The State Department has authority to demand disclosures of SSNs only when a passport is applied for. 26 U.S,C. sec. 6039E. Form DS-64 is not an application for a passport.

| 1. "It has been invalidated. You may not use that passport for travel." |
| The underlining on the first line is one space off to the left. Use of both bold and underlining is overkill. |
| What the State Department intends to say, probably in a new paragraph, is, "After you file this form, the passport will be invalidated. The passport may not be used by you,. Instead, the passport must be sent to the State Department." Neither bold nor underlining is needed. |
| 2. Protect yourself against identity theft! Report non-receipt of your passport book or passport card! |
| The exclamation marks are excessive. The statement is inaccurate. Reporting a lost or stolen passport does not protect anyone against identity theft. The information contained on the ID page of a lost or stolen passport is already available to the finder of the passport or to the thief. Identity theft is possible, because the horse is already out of the barn, no matter that a report about the loss or theft is made. |
| How is a passport applicant to know when he suffered non-receipt of a passport booklet or passport card, and, so, should make a report? The State Department does put any applicant on notice that he should file a report a specified number of days after submitting an application form to the State Department. |
| 3. There is case law to the effect that the IRS may demand that a person who files a document with the IRS, e.g., a tax return, do so under penalty of perjury. Let's assume that the case holding extends to the State Department. There is nonetheless no authority under which the State Department may require an applicant to subscribe to any statement of obligation or any statement of intention. |
