Aetna would like to comment on the proposed CY2021 Part C Reporting Requirements, Section VIII. Additional Telehealth Benefits. We appreciate the simplifications that CMS has made and we agree that the changes will increase the accuracy of reporting. We do have one question/recommendation.

For Data Element B, "If yes, list the number of Medicare Part B provider specialty types for which Additional Telehealth benefits are offered." Would CMS please confirm that CMS is requesting the total number of specialty types being offered? If so, we believe that the word "list" should be changed to "enter," which is the wording that that is used in the crosswalk.
