ELIGIBILITY

Approximately 12 Veterans and service members will be recruited per session to ensure that at least eight participate in each focus group, allowing for no-shows and last-minute cancellations.

SCREENING CRITERIA

VETERANS and ACTIVE DUTY SERVICE MEMBERS who deployed to contingency operations in the Southwest Asia theater of operations¹ at any time on or after **August 2, 1990, or**

Afghanistan or Djibouti on or after September 11, 2001.

- 1-2 Officers per group
- 2 Active Duty or current Reservists per group maximum

Airborne Hazards and Open Burn Pit Registry ENGAGERS:

- **100%** must have at least begun the process and determined **ELIGIBLE** for the Registry.
- At least 3-4 should have at least begun the questionnaire.
- At least 1-2 per group should have completed the questionnaire.
- At least 1-2 per group, where possible, should have completed the medical exam.

ELIGIBLE (Not Engaged):

- 3-4 per group should be unfamiliar with the Registry.
- 3-4 per group should have at least heard of the Registry.
- 1-2 per group- determined ineligible after completing automated DoD service record check, but potentially in error if self-reported service record suggests they are eligible for Registry.
- 1-2 determined eligible after completing service record check (but not yet begun the questionnaire after at least 3 months of notification) or have not received an eligibility response.

VA Employment

- VA employees and contractors are **EXCLUDED**.
- Anyone who primarily works in market research, communications or public affairs are **EXCLUDED**.

Gender

• At least one female per group (preferably, recruit two per group).

• 18-70

- Army (≈48%)
