TITLE OF INFORMATION COLLECTION:

Feedback on Survey of Earned Doctorates (SED) Restricted Data Analysis System (RDAS)

PURPOSE:

To collect feedback from SED users on the data elements and useability of the RDAS (<https://ncesdata.nsf.gov/rdas/#/>). The Restricted Data Analysis System (RDAS) is an online tool designed to expand public access to the Survey of Earned Doctorates (SED) data. The RDAS data tool is a customization of a mature and widely used data tool, the DataLab, that has been used by the National Center for Education Statistics (NCES) for more than 20 years. The DataLab meets all the statistical and reporting standards of NCES.

The SED RDAS data is based on a sample subjected to statistical procedures to produce estimates that reflect the entire population of doctorate recipients while protecting the confidentiality of individual level data. The RDAS provides a secure platform to access a comprehensive set of SED variables and empowers users to create complex data tables at the click of a button.

The SED RDAS was launched as a “soft release” in June 2021 and was not publicized or linked through the NCSES website. The link to the RDAS was only provided in the Data Tool section of the main SED web page. The goal of the soft release was to allow the SED data users to test the utility of the RDAS and to identify problems with the usability and functionality of the data tool before the official release planned for later this year. The purpose of this clearance is to recruit a more diverse group of SED data users to provide feedback on the data tool.
