The Bureau of Economic Analysis (BEA) strongly supports the continuation of the National Agriculture Statistics Survey (NASS) Eggs, Chicken, and Turkey Surveys. These important surveys are critical to the data quality of several key components of BEA's economic statistics. Although the farm sector is small, it is quite significant for many states and counties. The volatility of farm income at all geographic levels further necessitates the need for accurate survey results.

The Egg, Chicken, and Turkey Surveys are an integral part of measuring farm income and agricultural output. BEA uses data from USDA's Economic Research Service (ERS), which are based on the information collected by NASS on these surveys, to prepare estimates of farm proprietors' income and total personal income for county and States, as well as production at the State level.

The information on quantities and prices of poultry and eggs is also used to prepare estimates of farm product and income in the annual and benchmark input-output (I-O) accounts and the national income and product accounts (NIPAs). The attached table shows the various BEA program areas using the data and how the data are used. Please keep BEA informed about any modifications to these forms. We are particularly interested in any modifications proposed during the forms' approval process that would substantially affect our use of these data. Data used by BEA from the NASS Egg, Chicken, and Turkey Surveys

BEA Account Area	Data Used from Eggs and Poultry	Data Are Used
Regional Accounts	Production, Inventories, Prices	Indirectly through ERS-USDA accounts in measuring farm proprietors' income as part of total personal income for states and counties. Also used indirectly in preparing estimates of farm production as part of gross domestic product by state.
Industry Accounts	Production, Prices	To prepare estimates for farm product and income in I-O accounts. Prices used to derive "real" farm output.
National Accounts	Production, Prices	Used to prepare estimates for farm product and income in the NIPAs.
