The Bureau of Economic Analysis (BEA) strongly supports continued collection of the National Agriculture Statistics Service's (NASS) Floriculture Survey. This important survey is critical to the data quality of several key components of BEA's economic statistics. Although the farm sector is small, it is quite significant for many states and counties. The volatility of farm income at all geographic levels further necessitates the need for accurate survey results.

The Floriculture Survey is an integral part of measuring farm income and agricultural output. BEA uses the quantities and prices data from USDA's Economic Research Service, which are based on the information collected by NASS on this survey, to prepare estimates of farm proprietors income and total personal income for county and States, as well as production at the State level. The information is used to prepare estimates of farm product and income in the annual and benchmark I-O accounts and the NIPAs as well. In addition, data on prices received for farm products and published as an annual index are used by the Industry Accounts to estimate real farm output. The attached table shows the various BEA program areas using the data and how the data are used.

Please keep BEA informed about any modifications to this form.
