In § 250.842 there are 10 cost recovery fees; as well as 6 non-hour cost burdens for Professional Engineering (PE) costs:

- Submit application for a production safety system with > 125 components \$5,426 per submission; \$14,280 per offshore visit; and \$7,426 per shipyard visit. PE costs of \$126.47/hour.
 - o 1 submittal per year at \$5,426
 - \circ **Total** = 1 x \$5,426 = \$5,426
- Submit modification to application for production safety system with > 125 components \$605 per submission and PE costs of \$126.47/hour.
 - o 8 facilities with 3 modifications per year at \$605
 - \circ **Total** = 8 x 3 x \$605 = \$14,520
- Maintaining a regulatory compliance database for collection and distribution of information on production safety systems. This is for CTG SMART database
 - o 8 facilities at \$5000 per month
 - \circ Total = 8 x 5000 x 12 = \$480.000

- o Most difficult thing is trying to collect the non-hour costs associated with all the submittals.
