PART I.—GENERAL INFORMATION

Background.--This proceeding was instituted in response to petitions filed on January 12, 2022, by Chemical Products Corporation ("CPC" or "Petitioner"), Cartersville, Georgia. Countervailing and antidumping duties may be assessed on the subject imports as a result of these proceedings if the Commission makes an affirmative determination of injury, threat, or material retardation, and if the U.S. Department of Commerce ("Commerce") makes an affirmative determination of subsidization and dumping. Questionnaires and other information pertinent to this proceeding are available at https://www.usitc.gov/investigations/701731/2022/barium_chloride_india/preliminary.htm.

Barium chloride covered by these investigations is barium chloride, a chemical compound having the formulas BaCl_2 or $\text{BaCl}_2 \cdot 2\text{H}_2\text{O}$, currently classifiable under subheading 2827.39.4500 of the Harmonized Tariff Schedule of the United States (HTSUS). Although the HTSUS subheading is provided for convenience and customs purposes, the written description of the scope of this order is dispositive.

Importer.--Any person or firm engaged, either directly or through a parent company or subsidiary, in importing barium chloride (as defined above) into the United States from a foreign manufacturer or through its selling agent.

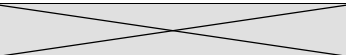

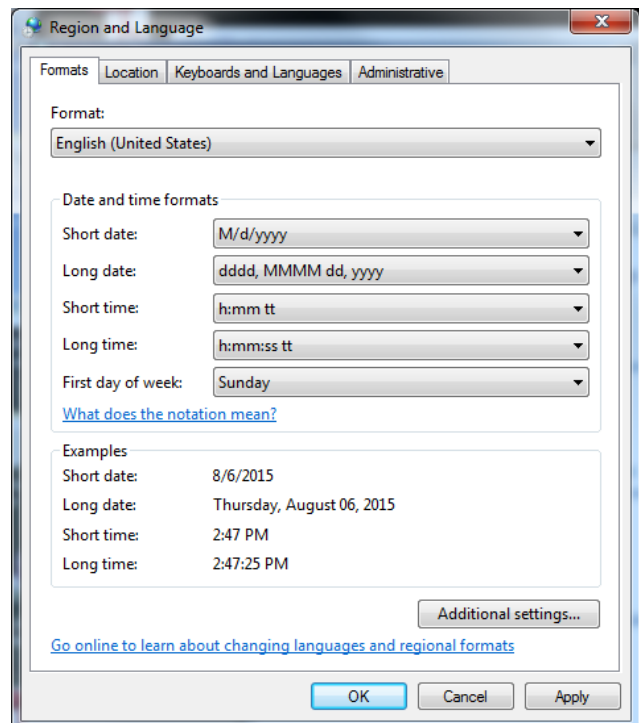
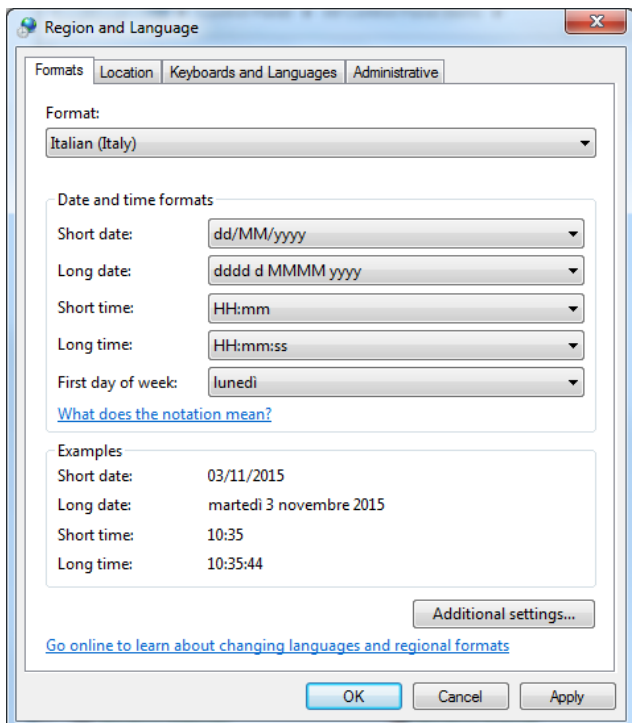

Many EU and other countries use the reverse where multiples of 1000 are delineated with periods (".") and fractions less than one are delineated with commas (","). The U.S. International Trade Commission's questionnaires are set-up in the United States with the U.S. number formatting. When this formatting interacts with a computer set to EU or other country number formatting, we believe this may cause this issue.
