

1. **MPBOA Medicare Part B Online Application (CMS-40B and CMS-L564 combined)** – *Released in May 2020*
The MPBOA allows customers to enroll online for a Medicare Part B Special Enrollment Period.

2. **SSA-455 Disability Update Report** – *Released in October 2020*
We mail the SSA-455 to claimants and beneficiaries as part of our continuing disability review process.

3. **SSA-1696 Appointment of Representative** – *Released in March 2021*
The online SSA-1696 allows claimants and their appointed representative to complete, sign and submit the appointment online.

4. **SSA-820 Work Activity Report – Self-Employment**– *Released in August 2021*
Claimants and beneficiaries use the SSA-820 to report self-employment work activity in both initial claims and post-entitlement situations. The form helps frontline technicians make work activity determinations in initial claims and continuing disability reviews (CDRs).

5. **SSA-821 Work Activity Report – Employee** – *Released in August 2021*
Claimants and beneficiaries use the SSA-821 to report work activity in both initial claims and post-entitlement situations. The form helps frontline technicians make work activity determinations in initial claims and continuing disability reviews (CDRs).

6. **HA-85 Request to Withdraw a Hearing Request** – *Released in August 2021*
Appointed representatives use this form to withdraw a request for a hearing. Claimants may use the form as well.

7. **SSA-552 Dedicated Account Use of Funds Statement** – *Released in September 2021*
Representative payees of children claiming Supplemental Security Income (SSI) use this form to acknowledge that they understand the rules that apply to dedicated accounts for children due retroactive benefits exceeding six times the Federal Benefit Rate (FBR).

8. **HA-86 Request to Withdraw an Appeals Council Request for Review** – *Released in September 2021*

Appointed representatives use this form to withdraw a request for an Appeals Council Request for Review. Claimants may use the form as well.

9. **HA-4608 Waiver of Your Right to Personal Appearance Before a Judge –**
Released in September 2021

Appointed representatives use this form to waive the claimant's right to appear in person before a judge at a hearing. Claimants may use the form as well

10. **SSA-1693 Fee Agreement for Representation Before the Social Security Administration –**
Released in October 2021

Appointed representatives use this form to request a fee for representing claimants before the agency. The online SSA-1693 is a companion to the online SSA-1696 Appointment of Representation form, as representatives generally submit these forms together.
