National Endowment for the Arts (NEA)’s Demystifying the Arts Public Funding Ecosystem
Event Survey

PURPOSE:

This information collection request is for an online survey of individuals who register to attend the NEA’s “Demystifying the Arts Public Funding Ecosystem”, an online, public meeting held May 4, 2022. The survey serves the following purposes: 1) to solicit opinions and feedback from attendees about the event; 2) gauge interest in topics for future events; and 3) gather information about organizational characteristics. Survey results will be aggregated and shared internally at the NEA to improve customer service.

DESCRIPTION OF RESPONDENTS:

Respondents will be individuals who register to attend “Demystifying the Arts Public Funding Ecosystem”. Individual attendees will be returning, new, and future grant applicants (nonprofit organizations, state governments, county governments, municipal governments, and tribal governments) to the NEA. Starting in April, the NEA will send out online invitations and promote the event to the public via social media, website, newsletters, and listservs.

Yes, there is a customer list that defines the universe of potential respondents. The customer list will be generated when individuals register in advance to attend “Demystifying the Arts Public Funding Ecosystem”. Event attendance will be capped at 1,000 individuals.

The survey will be sent to the entire customer list, there will be no sample taken from the universe of potential respondents. It will be distributed via SurveyMonkey or Qualtrics no later than an hour after the event and will stay open for approximately five business days. An email invitation and a follow-up reminder email will be sent to each potential respondent.
