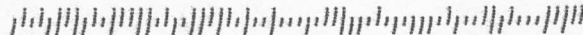

Re: Collateral Security Resolution and Collateral Pledge and Security

Practical utility:

- A. The information collection process is mandatory to overall regulatory projects.
- B. Amendments to (50 U.S.C. 4301-41) should be utilized for humanitarian and educational purposes implementing good faith and best practices for ADA suitability.
- C. Amendments to Auxiliary aids pursuant to 5 USC section 552 to which participants would violate under Article 1 of the U.S. Constitution in the nature of Religious, Treaties and protective covenants of Article VI section 2 of the Supremacy clause.

Burden of time:

- A. The burden of time (7.5 hours) should be increased (15 hours) to allow respondents to additional time for collection of information in conjunction with applicable laws.

Ways to enhance:

- A. Individuals sanctioned under regulatory affairs should receive notice to address corrections after examination of (18 month to 24 month) intervals to enhance inclusion based on character fitness, due diligence and capabilities upon final analysis of data to enhance necessary feedback and increase global targeting.
- B. Applied emphasis through information technology applications to prepare participants with best practices of maintaining and securing confidential communication with regards to National Security.

Ways to minimize burden of collection techniques:

- A. Proper recruitment and development of IT end-users of [trade secrets] to establish stronger senior executive programming to enhance inclusion and diversity.
- B. Additional ways to minimize is the implementation of E.O 12866

Estimate start up capital:

Start up capital allocated to project should range between \$25,000,000 to \$100,000,000
