

Request for Approval under the “Generic Clearance for Improving Customer Experience (OMB Circular A-11, Section 280 Implementation)” (OMB Control Number: 2900-0876)

TITLE OF INFORMATION COLLECTION: OPIA/VEO Customer Survey

PURPOSE

The Veterans Health Administration wants to know more about veterans’ experience when the COVID-19 vaccine and boosters. To achieve this, the Veteran Experience Office (VEO) will leverage VSignals to collect feedback through a short, low burden customer experience survey delivered as a URL for distribution through the VetResources newsletter email and will also be provided on a va.gov website. The survey consists of thirteen questions focusing on such elements as ease, effectiveness, emotion, and trust with the service. The survey asks for reasons the respondent might decide to receive or delay taking the vaccine, how many doses they have previously received, or if they saw a VA provider or non-VA provider. The survey also asks if the respondent would like to provide demographic data for their race, ethnicity, gender, and age. The survey is completed via a web-based survey design and contains general Likert-scale (a scale of 1-5 from Strongly Disagree to Strongly Agree) questions, checkbox, and radio button questions to assess the customer experience. The participant can choose to exit the survey at any time before submitting their survey response.

DESCRIPTION OF RESPONDENTS:

The survey will be offered to visitors of the va.gov/Trust website and through the VetResources newsletter email. There will be a statement asking the readers to take the survey if they have not received the COVID-19 vaccine. Participants will choose whether they want to click on the link, or whether they want to participate after opening the survey.
