## Good Evening Rebecca,

In closing out our work on the BSR Guide today, the team was checking on the format issue you brought to our attention in the Appendix. We noticed something that needs to be brought to your attention as it is a content error that needs correction. We saw a misalignment of the questions in Procurement and Property Management to the Principle and Practice. For example, under Principle 5 of Procurement (which deals with Minority Business Enterprise inclusion) most of the questions are a repeat of PR6 questions and they have no relationship to MBE inclusion. We found other similar duplicative areas and have entered them in our Tracker and have highlighted them in purple.

These will need to be corrected after Public Comment.

We further researched past versions of the Guide. The alignments were correct in Version 6.6 February 2019, but not after that. It seems that in the revisions to the Guide at that time (pre-Wdesk), when practices were moved around/cut and pasted, errors were made aligning the questions with the practices. Today's may be the first detailed read through of the questions relating them to practices since that time. Due to the data table automation that we have in place, this misalignment will be easy to resolve after public comment.
