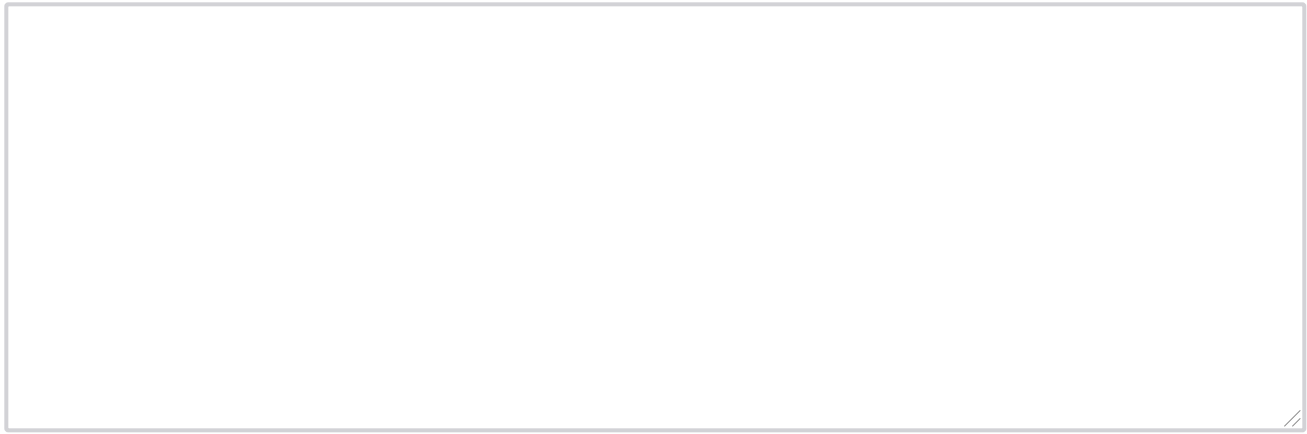

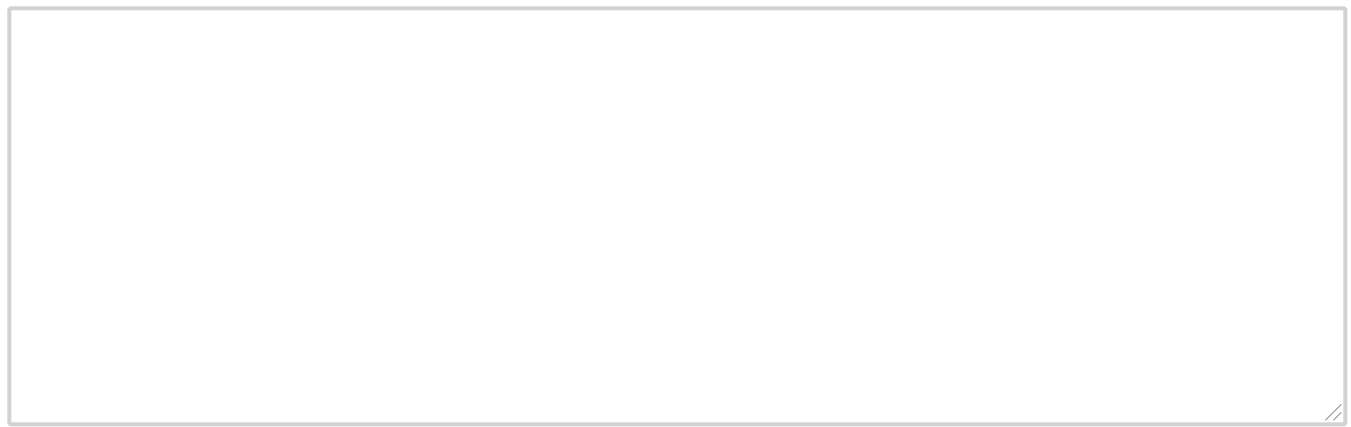

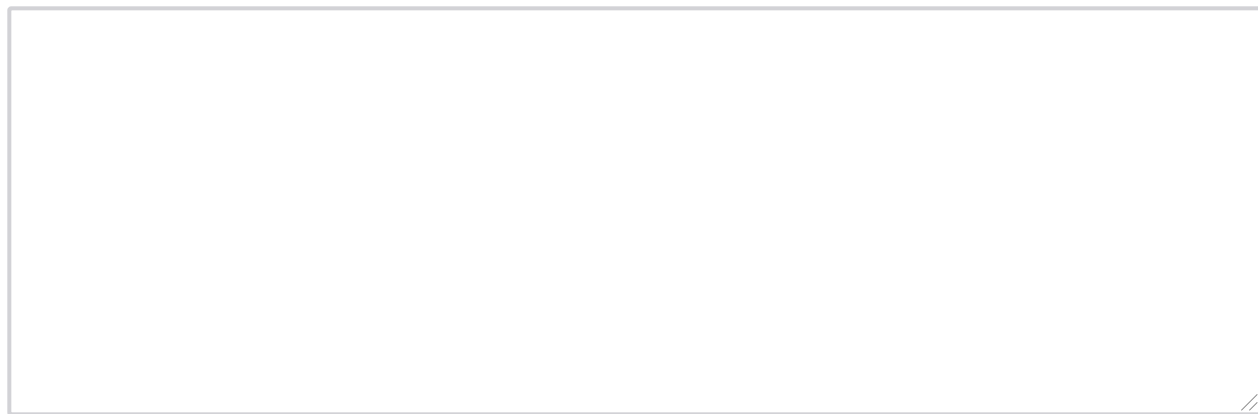

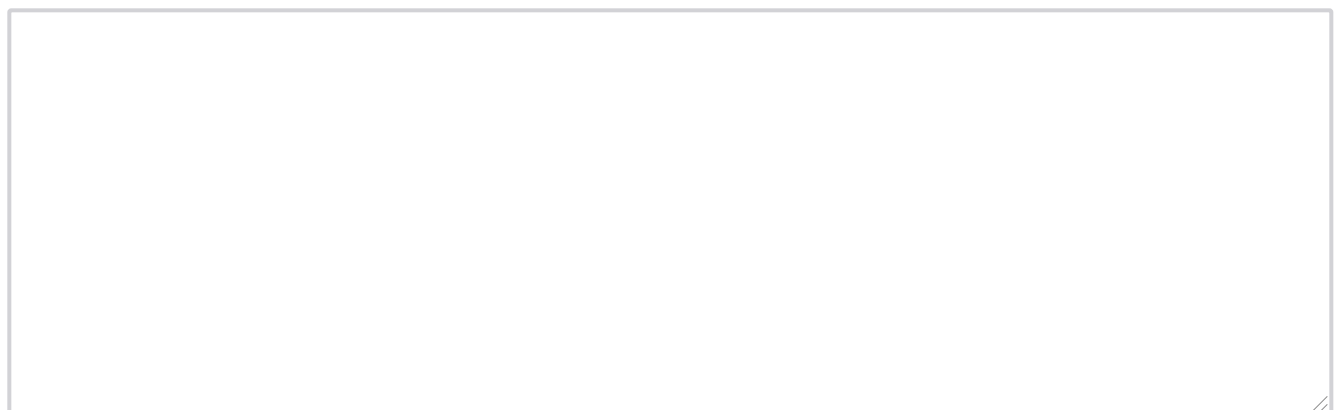
What language learning activities in particular were helpful for you?

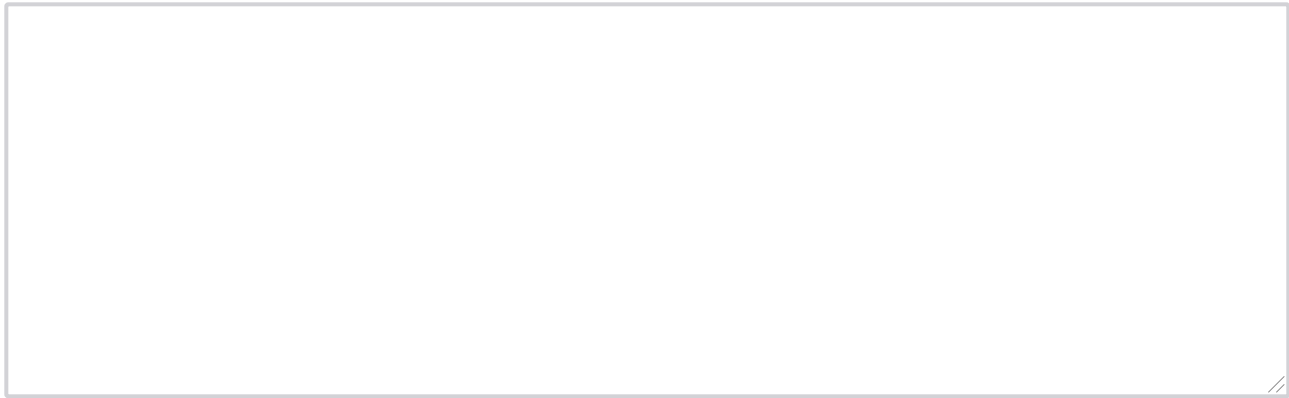

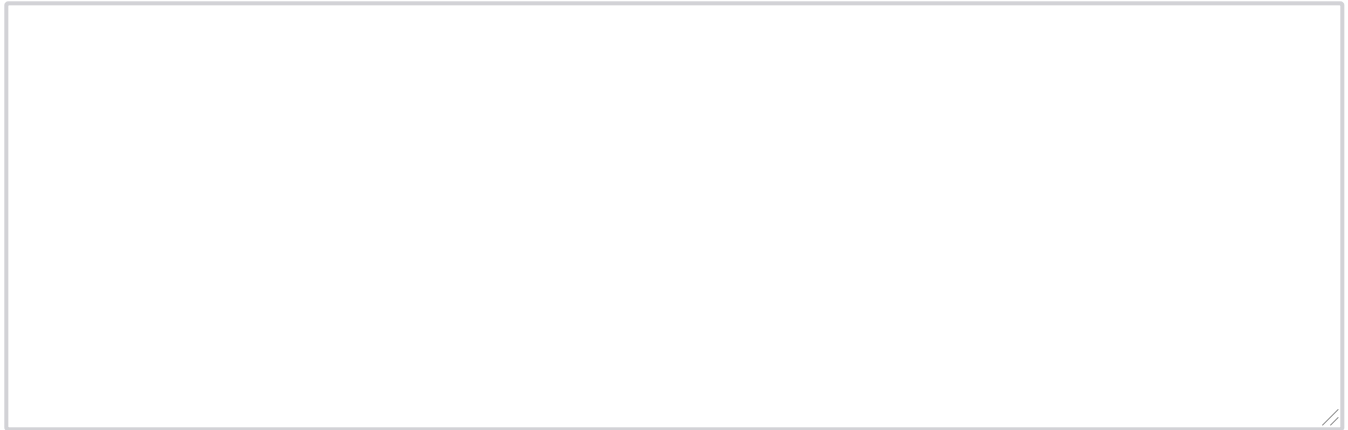
