The purpose of the *Interagency Working Group on Inclusion in STEM (IWGIS)* is to advise NSTC Committee on STEM Education on coordinating activities regarding inclusion in STEM fields across the Federal government, with a focus on identifying research, best practices, and policies on how to promote diversity and inclusion of all groups in the Federal STEM workforce, including women, people from underrepresented racial and ethnic groups, and persons with disabilities. The group was formed in 2017 in response to the American Innovation and Competitiveness Act.
