Thank you for providing an opportunity to review and comment on the information collection activities submitted by the United States Department of Agriculture regarding the Summer Food Site Locations for State Agencies.

Comments were requested regarding a) Whether the proposed collection of information is necessary for the proper performance of the functions of the agency, including whether the information shall have practical utility; (b) the accuracy of the agency's estimate of the burden of the proposed collection of information, including the validity of the methodology and assumptions that were used; (c) ways to enhance the quality, utility, and clarity of the information to be collected; and (d) ways to minimize the burden of the collection of information on those who are to respond, including use of appropriate automated, electronic, mechanical, or other technological collection techniques or other forms of information technology.

Below are comments from the Florida Department of Agriculture and Consumer Services, Division of Food, Nutrition and Wellness:

- Through submission of Form FNS-905: Summer Food Site Locations for State Agencies, FNS provides for state agencies to submit weekly updates of its approved summer meal site locations during summer operations of the Summer Food Service Program (SFSP) and the Seamless Summer Option (SSO) of the National School Lunch Program.
- Form FNS-905 collects the site name, location, and operating details, such as dates and times of the day the site is in operation. Since operating details can change on a daily



basis, limiting state agencies to weekly submissions of Form FNS-905 can cause site information to become outdated.

- We request that FNS considers accepting and publishing daily submissions of Form FNS-905 from state Agencies to ensure the most current site information is available to connect families to meals during summer operations.
