The Bureau of Economic Analysis (BEA) strongly supports the continued collection of data by the Internal Revenue Service (IRS) on Form 1065, 1066, 1120, 1120–C, 1120–F, 1120–H, 1120–ND, 1120–S, 1120–SF, 1120–FSC, 1120–L, 1120–PC, 1120–REIT, 1120–RIC, 1120–POL and all attachments to these forms collected as a "single collection of information" under OMB control number 1545-0123. The data collected on these forms are crucial to key components of BEA's economic statistics.

BEA uses data from these forms to prepare the national income and product (NIPA) accounts, the benchmark and annual input-output (I-O) accounts, personal income, and gross domestic product (GDP) by industry. The attached table provides more details on BEA's usage of the data.
