
We are requesting your participation in an interview regarding NSF-private industry direct partnerships. Westat and RAND, independent research organizations, have been contracted by NSF to conduct an evaluation of the benefits of NSF-private-industry direct partnerships, document what makes them effective, and develop recommendations for how they might be improved. This evaluation focuses on “direct partnerships” between NSF and private industry and addresses the benefits of such collaborations on researchers, NSF, industry partners, and the field. The study is also seeking insights on any improvements that could make these partnership programs more effective or easier to implement.

What is the purpose of the interview and what topics will it cover?

The interview is designed to obtain information on (1) the basic characteristics and strategies employed by projects that participated in the NSF-private industry direct partnerships; (2) how projects interacted with the industry partners; (3) the factors that affected the scope and conduct of both the partnership interactions and the overall project effort; (4) projects' outcomes; and (5) the added value of having private industry as a funder.

What will happen to the information you provide?

The Westat/RAND team will summarize the results from the interviews (i.e., across all projects participating in the study) in a report that will be provided to NSF. While your responses will be identifiable to Westat and RAND, the report provided to NSF will only focus on overall results. Westat and RAND will not report any individual responses to NSF, nor will they release any information about individuals participating in the interviews to anyone outside their organizations.
