Detectives from the Rhode Island State Police Internet Crimes Against Children Task Force arrested Thomas Goodman, 45, on May 17, 2018, after Electric Boat Security confiscated Goodman's cell phone when he violated company policy by using the cell phone on Electric Boat property. While searching the phone, Electric Boat security found a vast quantity of child pornography.

The phone was turned over to a North Kingstown Police Department detective, who confirmed that the phone contained child pornography..."
