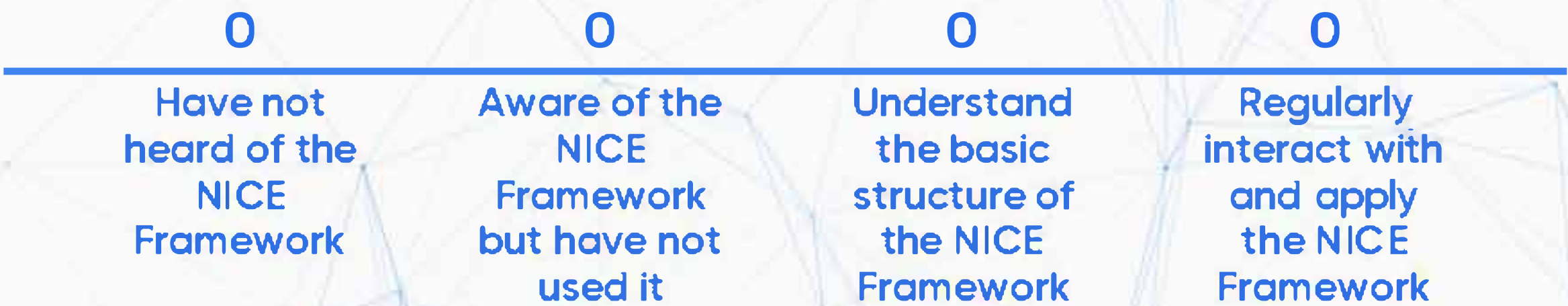

What is your level of familiarity with the NICE Framework?



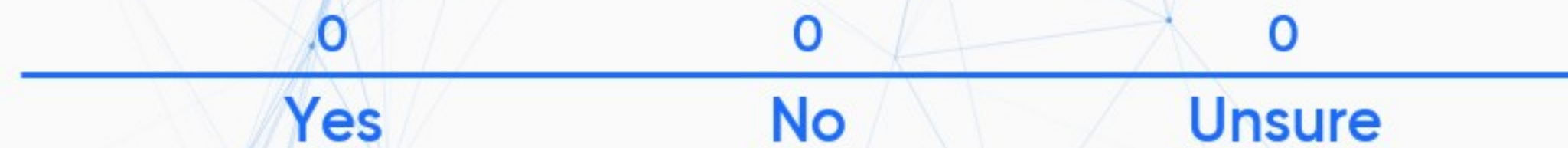
Do you know what is the difference between an on-ramp and off-ramp role?
