The Bureau of Economic Analysis (BEA) strongly supports the continued collection of data by the Energy Information Administration (EIA) for the EIA-914 Form, Monthly Natural Gas Production Report.

BEA uses information collected on this form to prepare the benchmark and annual input-output (I-O) accounts. The information from this form also has potential use for the estimates of gross domestic product (GDP). EIA combines data from form EIA-914 with data from forms EIA-176, EIA-857, and EA-910 to create aggregate end-use quantity and price data by sector. BEA's national economic accounts uses these end-use data to construct annual and quarterly indicators that are crucial to key components of BEA's industry statistics. Additionally, the information from these forms is used in the annual estimates of GDP by state.
