PURPOSE:

The purpose of this information collection is to gather information from users of applications that connect to VA’s Application Programming Interfaces (APIs). These users range from Veterans themselves to Veteran Representatives who help Veterans manage claims. This study aims to test the redesign of the authentication page so that users are sure they are connecting to the right user data since Veteran Representatives can also be Veterans. This will give users confidence they will access the data they need for their context after verifying their identity.

The respondents will be external users of applications that use Lighthouse APIs. They include Veterans and Veteran Representatives.
