Dear Ms. Hildebrand: In response to the above notice and request for public input, I write to make the following suggestions concerning the draft public assistance forms identified on FEMA's Web site¹:

- Request for Public Assistance, OMB Control Number FF-104-FY-21-131: On pages 3-4, under "Critical Service": Educational I recommend adding charter schools along with parochial schools to this item as charter schools are eligible for FEMA PA support.² On page 4, under the heading "Emergency Medical Care (diagnosis or treatment of mental or physical injury or disease) provided in [....", I recommend adding dental facilities, and federally qualified health centers and look-alikes³ to the list. Under the heading "Non-Critical Essential Social Service," I recommend specifically adding behavioral health facilities (inclusive of psychiatric, mental health or substance use disorder).⁴ On page 5, I would change "zoo" to "zoo, aquarium, veterinary or other animal care facility."
- Organizational Profile, OMB Control Number FF-104-FY-22-233: On page 4 under the heading "Which of the following best describes the organization?" I recommend adding "territorial government" to the list which would cover American Samoa, Guam and Puerto Rico.⁵
