## Director Joseph Wilson,

The Grid Deployment Office supports EIA's OMB proposal to reclear the EIA-111 without changes. GDO relies on data collected using the EIA-111 to issue and track authorizations for export of electric energy. As directed by 10 CFR 205.308,¹ authorization holders use the EIA-111 to report the gross amount of kilowatt-hours of energy transmitted (received and delivered) and the associated cost and revenue. GDO also relies on data collected using EIA-111 to issue and manage Presidential permits for the construction and operation of electric transmission facilities at the U.S. international border. As directed by 10 CFR 205.325,² permit holders use EIA-111 to report the gross amount of kilowatt-hours of energy transmitted (received and delivered), and the associated cost and revenue.

GDO uses the data collected through form EIA-111 to monitor active presidential permits, evaluate export authorization utilization, and reconcile export activity with active permit holders to take corrective action when necessary. GDO needs the data collected in form EIA-111 to facilitate the Export Authorization and Presidential Permit programs, inform transmission facilitation priorities, and to meet the requirements of our regulations.
