## To Whom It May Concern:

May this situation is already in your knowledge that form N-400 require some Important corrections with many parts so we strongly request you to please put your attention on this matter specially with the following part and modify to correct it to save the American society from the Fraud Marriages which happenes in our society each day and ruined many citizens lives forever.

## Form N-400 part, Who may file Form N-400?

- 1. A lawful permanent resident for at least five years and at least 18 years old:
