Thank you for your continued support of EIA's Petroleum Marketing Program. We are glad that the data from the EIA-14, *Refiners' Monthly Cost Report*, and the EIA-856, *Monthly Foreign Crude Oil Acquisition Report*, are useful to your work.

Federal Register Notice 2024-12198 covered the proposed discontinuation of the EIA-782C survey, *Monthly Report of Prime Supplier Sales of Petroleum Products Sold for Local Consumption*, that you mentioned in your comment. However, we have since learned that your office no longer requires these data to prepare estimates of the gasoline and oil component of personal consumption expenditures and that your office has found an alternative way to compute the real gasoline and oil expenditures that are included in GDP calculations.

We appreciate your feedback on our data offerings.
