TITLE OF INFORMATION COLLECTION: Blue Star Museums Registration

PURPOSE:

The purpose of this information collection is to collect registration information from museums who wish to participate in the Blue Star Museums (BSM) program annually each summer. BSM is a program that offers free admission to museums for all active duty military personnel and their families, and typically runs from Armed Forces Day through Labor Day each year. These include children's museums, fine art museums, history and science museums, and nature centers.
