### # Legal and Privacy Concerns

#### # Safety and Security Risks

Restrictive passport policies heighten the risk of harassment and mistreatment, especially in international travel. Many countries criminalize or discriminate against transgender individuals, and mismatched documents can lead to scrutiny, denial of entry, or even arrest. The U.S. should not enforce policies that increase these risks.

### # Harm to International Relations and Travel

A government forcing its citizens to carry inaccurate documentation disregards the mental health needs of a marginalized population, affecting well-being and perpetuating systemic discrimination.
