On Tuesday, April 8, 2025, NATL VICTIM STAT SUPT PRG (NVSSP), Project Number 6914, was presented to the full Board virtually. Pursuant to 28 CFR 46, the IRB reviews all studies involving research on human subjects. The Bureau of Justice Statistics funds this project.

Previous IRB approval included support for sample design and reviewing data from another project.

This request includes testing new content for the National Crime Victimization Survey. Content will involve measuring cybercrime; specifically stalking, identity theft, and fraud. This test includes web surveys with web panel participants and cognitive interviews with respondents from the web survey. In addition to testing new cybercrime questions, Westat will test revisions to the race/ethnicity questions.

Action Requested: Review of the amendment request, project summary, protocols, informed consent forms, resources, recruitment and help desk materials, and a distress protocol and training.

Action Taken: Pursuant to (28 CFR 46) 45 CFR pt. 46 and the information provided, the Westat IRB determined that this research met criteria for classification as minimal risk and assigned it a Conditional Approval.

On Thursday, April 24, 2025, responses to conditions were reviewed and accepted under expedited authority (Per 28 CFR 46). Per 28 CFR 117c [45 CFR 46 117c], a waiver of documentation of informed consent is also approved as the research is no more than minimal risk and involves no procedures for which written consent is normally required outside of the research context.

As the Project Director you are also responsible for the following:

- Acknowledging that this project's initial approval expires on April 24, 2026.
- Submitting this study for a continuing review before April 1, 2026.
- Acknowledging that IRB approval is required before any new or modified research activities are conducted or when there is problem involving risks to human subjects.
