It assists Veterans with Service-connected disabilities and an employment handicap to prepare for, obtain, and maintain suitable employment. The VA Form 28-1900, titled "Application for Veteran Readiness and Employment for Claimants with Service-Connected Disabilities," is the official form used by Veterans and Service members to apply for the Veteran Readiness and Employment (VR&E) program, also known as Chapter 31. This form is an application used to initiate the process of determining eligibility to receive a comprehensive initial evaluation for VR&E benefits and services, which help Veterans with Service-connected disabilities prepare for, find, and maintain suitable employment, or achieve maximum independence in daily living if employment is not feasible.
