Notice of Declaration of Statement of Policy for publication in the Federal Register, under the Acts of Congress and the Constitution of the United States

I am requesting Approval for adding statutory requirements, as required to align TAR with new FAR and request an Exemption for the TAR Forms due to compliance with safeguarding DOT sensitive data controls, under the Department of Defense and the Secretary to assign the personnel for Executive Agent for the purposes, the Office of Management and Budget, OSPE in conjunction with the Office of Information Technology, the Office of Personnel Management and the Administrator, the Department of Homeland Security, the Department of Justice, the Department of State and the Secretary, the Department of Interior and the Secretary, the Department of Commerce and the Secretary, the Department of Energy and the Secretary, the Department of Health and Human Services and the Secretary, the Federal Aviation Administration and the Administrator, Office of Veterans Affairs, Congress, Governor, all agencies and departments involved, on my behalf and Orders of the President of the United States, Restoring Common Sense to Federal Procurement, to allow for contracts for acquisitions to cloud computing services, data jurisdiction, personnel screening, security alerts, etc. that are required for the Small Business Administration Program and Certification Regarding Tax Matters on my behalf. The revised Executive agency contracts will allow for the appropriate funds for contracts with entities not meeting Veterans' Employment reporting requirements, under the Small Business Act, the National Defense Authorization Act for Fiscal Year 2013, the American Recovery and Reinvestment Act, and the National Security Act of 1947, will allow for the necessary contracts related to flying American, validation of proprietary data, for access to Rights in technical data, to protect against harm of materials and supplies mined, including protection from explosive ordnance, and the participants in the collection of intelligence for law enforcement purposes of personnel
