The following is a list of comments regarding ORR Revisions to the ORR-3 and ORR-4 forms. They were compiled from comments that URM caseworkers submitted during the trial period.

It took caseworkers approximately 45 minutes per form

The form is visually chaotic and it is easy to miss required fields

Many fields are not large enough for appropriate answer (i.e. Alien Number field)

All State fields are formatted in "Wingdings" font

All Zip Code fields are formatted to delete the first "0" in the number sequence

Caseworkers had questions regarding "Service Type" and "Educational Benefits" fields. It appears that it would be helpful to have explanations for these fields.

To Whom It May Concern:

The California Department of Social Services (CDSS) is responding to the request for comments regarding the newly revised Unaccompanied Refugee Minor (URM) Placement Report and URM Outcomes Report, ORR-3 and ORR-4 respectively. These reports are used to collect data for the federal URM program, a refugee foster care program administered by the United States Department of Health and Human Services, Office of Refugee Resettlement (ORR).

The CDSS has the overall responsibility for administering the Refugee Resettlement Program in California, including the URM program; and, in that role, we oppose the implementation of the revised ORR reports due to:

- the drastic increase in the amount and complexity of the new data required;
- the additional workload burden this will place on California at a time when our state is faced with reduced staffing and fiscal challenges; and
- adequate time has not been allowed for our state to review the new reports or for ORR to provide an explanation of why these changes are necessary.

Based on these reasons, CDSS requests that the OMB delay the implementation of the revised reports and open a dialogue with state and local stakeholders to provide input on the need for the revisions.
