<b>1194.22(m)</b> When a web page requires that an applet, plug-in or other application be present on the client system to interpret page content, the page must provide a link to a plug-in or applet that complies with 1194.21(a) through (l).	<b>N/A</b>	No applets or plug-ins required.
<b>1194.22(n)</b> When electronic forms are designed to be completed on-line, the form shall allow people using Assistive Technology to access the information, field elements, and functionality required for completion and submission of the form, including all directions and cues.	<b>Full</b>	The developers for Survey Monkey have gone out of their way to create truly accessible forms. The work correctly and they work well with Screen Readers. A very good job on this key provision for Survey Monkey.
<b>1194.22(o)</b> A method shall be provided that permits users to skip repetitive navigation links.	<b>Full</b>	Headings markup (h1, h2, etc) provides convenient navigation through the questions of the Survey.
<b>1194.22(p)</b> When a timed response is required, the user shall be alerted and given sufficient time to indicate more time is required.	<b>N/A</b>	No timed responses.
