Pursuant to Sections 45.4 and 45.9 of the regulations of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. §§ 45.4 and 45.9 (2010), enclosed is the Informational Report of Interlocking Positions for Mr. Shawn Sheehan. Pursuant to 18 C.F.R. § 45.9(a), XO Energy NY, LP, XO Energy MA, LP, and XO Energy MW, LP are all affiliates with the following ownership structure: XO Energy NY, LP is owned 99 percent by Mr. Shawn Sheehan and one percent by its General Partner, XO Energy NY, Inc.; XO Energy MA, LP is owned 99 percent by Mr. Shawn Sheehan and one percent by its General Partner, XO Energy MA, Inc.; and XO Energy MW, LP is owned 99 percent by Mr. Shawn Sheehan and one percent by its General Partner, XO Energy MW, Inc. Since each public utility on which the Applicant serves as an officer or director meets the requirements of Section 45.9(a), the Commission authorizes the holding of that interlocking position upon receipt of this Informational Report.

III. CONCLUSION

WHEREFORE, for the foregoing reasons, the Applicant respectfully requests that the Commission accept for filing this informational report for interlocking positions.

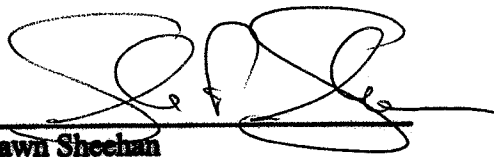

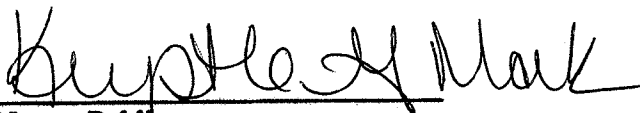
