Dear Mr. Denale:

The International Rescue Committee ("IRC"), a leading humanitarian assistance organization providing relief to refugees and the displaced worldwide, and a long-standing partner of USAID, in response to the Notice of Public Information Collections republished on October 2, 2007, resubmits and incorporates herein for the record all of its previously filed comments on the proposed collection of information by USAID through the Partner Vetting System (PVS) as put forth in its August 24, September 18, and September 21 response letters (attached hereto and incorporated herein for the record). In IRC's view, the October 2 notice does nothing to remedy the serious deficiencies in USAID's proposal to collect information through the PVS, deficiencies IRC has articulated in all of its previously filed submissions. The October 2 notice appears to have simply published the Partner Information Form that USAID proposes to use to collect information.

The PVS still remains overreaching, unwarranted, and overly burdensome, lacks statutory basis, raises serious privacy concerns, and will certainly result in added insecurity and harm to the NGO community and overseas staff. In addition, the Partner Information Form as proposed is overbroad, vague and full of ambiguities. It fails to adequately identity which individuals are covered by the form. In fact, the definition of "key individual" to include "any other person with significant responsibilities for administration of the USG-financed activities or resources" is so vague and ambiguous that an organization submitting the information would never know if they submitted sufficient information to USAID. In addition, the form confirms that USAID's fifteen (15) minute burden estimate has no factual basis. After reviewing the form, IRC is certain that the burden estimate is closer to one (1) hour to complete the form for each individual vetted and

perhaps longer, considering that it is unclear who is a "key individual", with the result that any organization submitting the form would have to guess as to on which and how many of its employees it would need to provide information.

Accordingly, IRC strongly urges USAID to withdraw its July 17, July 20, July 23 and October 2 notices and reconsider its proposal for a vetting system in consultation with the NGO community.
