Thank you for your e-mail and for inquiring about the proposed DS-5513 (Supplemental Questionnaire to Determine Entitlement for a U.S. Passport) or DS-5520 (Supplemental Questionnaire to Determine Identity for a U.S. Passport). We thank you for your interest and take this opportunity to clarify a few misconceptions about these forms.

The DS-5513 and DS-5520 are questionnaires designed to help determine the citizenship and identity, respectively, of passport applicants. The DS-5513 and the DS-5520, are not designed to replace the DS-11, Application for a U.S. Passport, but rather to supplement the application when the applicant submits evidence that is insufficient to meet his/her burden of proving citizenship or identity. The Department estimates that such supplemental information will only be requested for a small number of applicants, estimated to be less than 0.5% of applications received annually. For information on what documentation is required when submitting a DS-11, please refer to page two of the instructions.

The DS-5513 and DS-5520 are based on the original Biographical Questionnaire for a U.S. Passport, posted on the Federal Register for public comment on February 24 page (page 10421) and closed April 25.

Comments we received from the original Federal Register posting were considered, and several suggestions were incorporated into the current version of the forms. The Department split the form into two shorter forms: the DS-5520 for identity questions and the DS-5513 for entitlement. Both revised forms assure applicants that failure to answer every question will not necessarily preclude passport issuance, as the responses to the questions in the forms are considered in their entirety.

In response to comments regarding burden and privacy concerns, the proposed forms amend many of the questions to more accurately obtain the information the Department is seeking. For example, the proposed DS-5520 limits the number of past employment and residences requested. The Department also removed the question regarding past supervisors and employers' contact information based on public comment. On the DS-5513, the questions concentrate around the time of the applicant's birth and there are no longer any questions seeking information about periods of time beyond the applicant's 18th birthday.

The Department also received comments that expressed concern over the ability of an applicant who is adopted or elderly to answer the DS-5513's questions on birth circumstances. The form asks a wide range of questions related to the circumstances and facts surrounding an applicant's birth in order to accommodate the various

situations in which Americans are born, whether hospital, home birth, non-institutional birth, etc. The Department realizes that most information an applicant supplies for this questionnaire surrounding his/her birth will likely come from other sources and takes this into account during the adjudication process. In addition, many of these questions may not apply to some applicants; however, in those instances where the questions are relevant, the supplemental form gives the applicant an opportunity to provide additional information that may support passport issuance.

We hope the above information addresses any concerns you may have.

I understand the need to verify whether a person is legitimate before giving him/her a passport. The requirements needed to get a passport must be valid and attainable and the rules for getting a passport should be equally valid to all applying.

I recently applied for a passport and was asked to provide the following information:

- 5 personal documents which are 5 years or older that include either a name or a signature
- The address of every place I ever lived, and the years I lived there
- The name and address of every job I ever had, my supervisors name and phone # and when I worked there
- All of my families information on when and where they were born
- When and where I was baptized
- The name, and address of every school I attended and when I attended

I also had to list where I live now, and my Social Security #

All of this had to be mailed to a location that I can't even contact. Needless to say, if this information did not make it to its final location I would have easily lost my identity; as someone with ill intentions would know everything about me.

What if I am adopted, or my parents died, or I was born at home? I would be missing important parts of the requirements. Then how would I get a passport?

I couldn't come up with 5 pieces of identification that are 5 year or older that have the information requested. That said, I was told to "do the best I can". Then it is up to the person reviewing my application whether it is good enough. It shouldn't be a guessing game whether or not a person gets approved for a passport. There needs to be black and white guidelines. Without clear guidelines you allow for discrimination in the process and discrimination will open the pathway to lawsuits down the road.

It took nearly 10 hours (or 600 minutes) to gather this information, far greater than the 85 minutes estimated. How long will it take someone to review the 20 pages of documents I sent in? With a 1.5 Trillion dollar deficit; does the government really have the resources (funds) to commit to this endeavor?

As an example of non-unique cases that this will apply to: Home-birthed, and home-schooled children - following the required laws of their respective states very often are cases of Delayed Birth records being filed and very little 'certifiable' school records - regardless of the thoroughness and completeness of those records. Additionally, low to no medical records is often the case for these families as they tend to be healthier in general. Finally there is no requirement to obtain a SSN as a matter of citizenship, making the request for this information as a form of identification merely supportive.

As I have received one of the "unofficial" and thus optional(?) forms from the agency, and have been dealing with the application process over the course of SIX YEARS (!) even though my spouse and I are US citizens, I have a fairly good frame of reference for the following objections to this form:

- 1) As the obtainment of a Social Security Number (SSN) is not a legal requirement in the United States requiring it on a form that potentially restricts a US Citizen's Right to travel is an unacceptable form of coercion by the Federal Government on it's citizen's expectation to be left alone. In fact the base application already requires this information and supplies a resolution in the case of citizens NOT having said SSN.
- 2) Requiring the delineation of relatives is either
- a) redundant This information should either be available to the agents processing the application via Census records or Tax records as a matter of due process, the understanding that permission to access this information is granted by the application for a passport.
- b) ultimately moot, as the parents are already required to file evidence of their status as US citizens on the standard application.
- 3) Section C is also redundant, as approval and submission of a Standard, or Delayed, Birth Certificate from a US State or possession should be considered as sufficient since much of the information requested on the form must have been supplied in order to obtain the Birth Record. Further, the supplemental information (mother's work history, and pre\post partum treatment, etc) has no bearing on the child's status as a citizen.
- 4) Section D, E, and F are onerous, and moot. Any search of public records would return much of this data to a lay person with internet access, to expect that Federal Government Offices have less ability to obtain this information stretches the bounds of common sense into the intentionally onerous and potentially 'Jim Crow" like in its relevance. And as a matter of course, the access to this information should be

considered granted for the duration necessary to process the standard application.

Such a "Supplemental Worksheet" as DS-5513, should either be considered as required of all applicants (in which case your estimates are extremely low), or not required at all (as much of the information is required in the course of obtaining other supporting documentation).

In either case consideration of this data collection should result in a denial of OMB approval as either too onerous in the case of uniform application, or unnecessary in the case of ancillary documentation.
